

**REGULATIONS FOR THE USE OF THE STADIUM**  
**RULES OF CONDUCT**

**Definitions**

- For the purposes of this Regulation the term "sports facility" means all areas of relevance, including the restricted area outside.
- "Club" means BOLOGNA FC 1909 SpA

**General Rules**

- The entrance and the stay in any capacity within the sports facility are governed, for anything not provided for by law, by this Regulation, written based on the guidelines approved by National Observatory on Sports Events in Article 1-g (DL 28/2003 converted and amended by Law 88/2003).
- The purchase of the ticket involves the express acceptance of this Regulation by the purchaser and the obligation to respect the same. Such acceptance and obligation extend also to the assignee of the ticket or other title that allows access to the sports facility, in cases where such transfer is permissible under general law and specific regulations of this field.
- Whoever, except in cases provided for in Article 1-d, paragraph 7 (DL 28/2003 converted and amended by Law 88/2003), have access to facilities in violation of the relevant Regulation governing the use or decide to remain inside the sports facility when a breach of those rules involves the expulsion (determined on the basis of video-photographic documentation or other objective evidence) is liable to a fine of between 100 to 500 Euros. The penalty may be increased up to half of the maximum if there is evidence that the offender appears has already been sanctioned for the same offense, committed in the current season, even though the infringement occurred in another sports facility.
- In the case referred to the previous period, the offender can be applied the prohibition and the requirements of Article 6 of the Law of 13 December 1989, n. 401, for a term not less than three months and not exceeding two years. The administrative penalties referred to in this Article shall be imposed by the Prefect of the province of the place where the sports facility is.
- Even outside of the cases mentioned above, the club has the right to expel from the sports facility anyone who does not comply with the Regulation governing the use and may refuse to such persons the entrance to the sports facility at subsequent events.
- The title of access to the stadium is personal and cannot be transferred to third parties, except in cases and approved by the club and by the rules of law on the subject.
- It is forbidden to buy admission tickets to the sports facility in violation of provisions used to separate the supporters of the teams. Failure to comply with this prohibition may lead to expulsion from the sports facility.
- For access to the sports facility it is required to hold the "Tessera del Tifoso" (Fan Card) ticket and a valid identity card to be shown at the request of the stewards, to verify the correspondence between the holder of the access title and the holder of the same.
- The title of access must be kept until the exit of the stadium and shown upon request of the stewards.
- The spectator has the right / duty to occupy the place assigned and, therefore, with the purchase of the tickets will not occupy different places, although not used by others, except as expressly authorized by the club organizing the event . If the club or the police authorities for any reason deem it necessary to take the viewer a different place from what is indicated on the ticket, he has a duty to comply with the instructions received.
- It is mandatory to comply with the instructions of the stewards and, in general, the control personnel and security personnel in the stadium; the viewer can be submitted by stewards, using metal detectors and "pat down" checks in order to prevent the introduction of illicit materials, prohibited and / or dangerous and is required to follow the directions given by the stewards. In case of lack of consent to the controls of the stewards the viewer will not have access to the stadium.

**Within the sports facility IT IS FORBIDDEN:**

- Express any form of racial, ethnic, religious, or other manifestations of intolerance with choirs or writings.
- Stand near the steps, exits, entrances, along the access for entrance or exit ways and on the stairs without a justified reason.
- Climbing on the structures of the stadium.
- Damaging or tamper in any way the stadium's facilities, infrastructures and facility services.
- Introduce or hold poisons, toxic substances, flammable or dirtying materials and drugs.
- To bring animals of any kind inside the stadium.
- Introduce or sold alcoholic beverages to a higher grade than 5 °, except derogation licenses for particular areas, issued by the competent authority, with the approval of the Police.

- Introduce or hold stones, knives, objects which can hurt or can be launched, sound instruments, systems for emitting light beams (laser pointers), explosives, pyrotechnics, smoke bombs, firearms, and, more generally objects that may disturb or endanger the safety of all persons present in the system; in case of rain, or precipitation forecasts, it is forbidden to bring umbrellas with sharpened tip.
- Expose material that might obstruct the view to other fans or emergency signs or that would impede the escape routes, including to the pitch;
- Make leafleting or sales of any kind or with any purpose unless authorized in writing by the club;
- Introduce and / or sell within the sports facility, drinks contained in cans, glass bottles or plastic; drinks must be provided in paper or plastic cups.
- Introduce and / or display banners, signs, horizontal banners, pennants, documents, drawings, printed or written material containing propaganda to political doctrines, ideological or religious statements or concepts that incite racial hatred, ethnic and religious hatred, or that could hinder the smooth running of the event and in any case not explicitly authorized by the Operational Group for Security (GOS) at the request of the club. The same cannot however be exposed in areas other than those set by the club and will be removed at the end of the event;
- Organize unauthorized choreography or other than those authorized by the Operational Group for Security (GOS) at the request of the club;
- Enter and remain inside the sports facility while intoxicated or under the influence of drugs or psychotropic substances. Also we remind you that it is a crime to: covering the face, the possession of arms, the display of emblems or symbols of associations that spread discrimination or violence on racial, ethnic, national or religious incitement to violence during sports competitions, the possession, the launch and use of hazardous materials and fireworks, the climbing of the separators and the pitch invasion.

**Warnings:**

- In case of temporary disability involving personal use of instruments of a walking aid (like crutches or similar), the entrance to the stadium in the relevant fields of admission will be granted only upon presentation of a medical certificate stating that the subject indicated "is able to walk properly in an autonomous way, as long as provided with the instrument of aid prescribed in the certificate". In the absence of this certificate, the viewer, depending on the availability of seats and with GOS approval, will have to sit in the specific area reserved for the disabled.
- It should also be noted that the sports facility is controlled by a system of audio-video recording placed both inside and outside. Data are processed in accordance with the provisions of Legislative Decree 30 June 2003 n. 196 and D.M. 06/06/2005.
- Any person attending to a sport event at the stadium, recognizes that it is a public event and then accepts and authorizes any future use of any audio and video recordings that could be made and can be made free use of her voice, image and look for means of live or recorded video projections, radio or other or recording, photographs or any other current technology and / or future;
- It is not allowed to use and enter the sports facility with recording systems (audio/video), video cameras and cameras;
- Any person attending a match cannot record and / or transmit sound, images and / or descriptions of the stadium or the game (as well as any result and / or statistics of the Match) other than for private use;
- However, it is strictly forbidden to share through internet, radio, television or other current and / or future media, sound, images, descriptions, results and / or statistics of the match as a whole or one of its parts, or assist other persons in the performance of such activities;
- The use of mobile phones is allowed in the stadium for the exclusive personal and private use.
